Smith River trips begin with pick up from a MTFFC representative at your arrival airport the day before your launch date; or if you are driving, we will meet you at the provided hotel lodging in White Sulphur Springs. Please refer to the planning sheet for a full description of inclusions, exclusions and trip details.

A 50% non-refundable deposit is required to secure your dates. This deposit will only be applied to a future rescheduled trip if cancellation occurs with more than **120 days notice**. With less than 120 days' notice, a refund will be available based upon our ability to refill the seats. A "restocking fee" may apply if seats are resold at a discount due to short notice. The remaining balance is due 45 days prior to the first scheduled day of the trip. Preferred payment methods are bank ACH, credit card, or check. Upon receipt of this booking form, an invoice will be emailed via Quickbooks to you within 7 days including secure links for Credit Card or ACH payments. Credit card companies are charging increasingly exorbitant processing fees, so ACH payments are always REALLY APPRECIATED! **Checks can be mailed to the address at the bottom of this form.**

An experienced angler knows that the best-planned trip can be impacted by the unexpected. Travel insurance is something you may want to consider. These plans can typically cover **Trip Cancellation for any reason**, Medical Evacuation, Sporting Equipment Coverage and much more. It is reasonably priced (about 5-10% of the cost of the trip.)
